## Forest rope course – Users Conditions

1. Before using the forest rope course every participant has to take note of these conditions, and confirm this by his/her signature. The legal guardian has to read through these conditions and talk them through with the underaged participants before they enter the 'Action Forest'. The legal guardian confirms with his/her signature that he/she has read through the conditions, talked them through with the underaged participant and accepts them. (The name declaration of the legal guardian and the participant is essential). I participate in the 'Action Forest' on my own responsibility.
2. The use of the 'Action Forest' is linked with risks and happens on every participant's own responsibility. For the commitment of the 'Action Forest' counts cypher 7.
3. The forest rope course is appropriate for participants aged six years onwards and a height of at least 4 feet 2 inches, who do not suffer from any deseases, do not have any physical nore psychological disturbances which might bring along any dangers for the participant him-/herself or other participants in the 'Action Forest'. People who are alcoholised or are on any other drugs are not allowed to enter the 'Action Forest'. Children under the age of 12 are only allowed to enter the park in the company of an adult.
4. Objects (such as jewellery, mobile phones, cameras etc.) may not be taken along as they might illustrate a danger for the participant him-/herself and for other participants.
5. Every participant has to take part in a safety introduction consisting of a practical and a theoretical part. All instructions given by the guides are committing and are to be obeyed. Any offense can lead to the exlusion from the 'Action Forest'. Any claims that occure from offense against the instructions from 'Action Forest' and its guides are not accepted.
6. The safety equipment which was handed ou by us consisting of a belt, connecting line and a helmet is not to be taken of while using the rope course, nore is it allowed to hand the equipment to other people. The safety equipment has to be properly used. The whole safety equipment has to be handed back after 3 hours. After 4 hours one has to pay another 4,-€ After that for every extra hour another 4,-€ The safety carabiners have to be hooked into the safety lines at any time. While klicking the carabiners from one wire in the next one, there always has to be left one carabiner on a wire. Never ever you are allowed to klick out both carabiners at one time. If you do this you are not allowed to go on!!!In case of any doubt contact the guides.
7. 'Action Forest' is liable for personal damage in the legal regulation. For property damage and capital damage 'Action Forest' is only liable by intention or wantonly negligence by the operator or a person entrusted with the leadership of an event.
8. In order to enter he black parcour one has to be 16 years of age. Each exercise can only be used by maximum one person. On each platform there may only be three people maximum at a time.
9. 'Action Forest' reserves the right to expel persons from the park that do not follow these conditions. 'Action Forest' reserves the right to close the park in case of safety reasons such as rain storm. In such a case the entrence fee is not payed back. In case a participant ends the visit early on his/her own wish the entrence fee is also not payed back.
